#### Re: Heartland Community Wind AGM: 8 July 2017

You have hopefully received the date notification for this year's Annual General Meeting, the second for the Society. Please find attached to this letter the papers for that meeting.

Please aim to be at the venue by 14.00 to allow time for registration, a cup of tea etc. AGM business proper will start at 14.30 and will normally take around 60 to 90 mins. If you are unable to make it, we would be grateful if you would return your proxy voting form attached, by noon on Wednesday 5<sup>th</sup> July so these can be included in the voting.

#### Heartland Community Wind – Directors' Report

The period since our last AGM in June 2016 has been eventful, with plenty for your Board to do. We meet monthly by phone, and we always have a full agenda!

The overall picture is that our turbines are performing very well and the prospects for the Society are excellent. We have however continued to encounter some costly issues. Along with the significant delay in getting the turbines fully operational in early 2016 (as covered in last years' AGM report), these mean the Society is not in a position to pay out interest or community fund this year.

#### Making Good


All the key issues we have faced relate to the rush to install to meet the deadline for the Feed-in Tariff. As members will recall, the turbines were installed in blizzard conditions in December 2015, only narrowly ensuring that they were built in time to beat the significant drop in Feed-in Tariff.

The bad weather during the install period meant that our contractors caused more damage to roads and tracks than we might otherwise have happened. This turned into a significant issue as the year went on, with both the neighbour whose land we crossed and Perth and Kinross Council seeking reparations for the damage caused. Much of the latter part of 2016 was taken up with negotiations, site visits, and obtaining quotes. The upshot has been that despite every effort being taken to reduce costs, we have incurred costs totalling £55,000 – a 3% overrun on construction costs. Most of this relates to the repair of the U173 Kinross to Amulree road. Members familiar with this route will know that this is a very small mountain road and unfortunately our heavy equipment did cause damage all along the stretch we used.

We are happy to say that both Perth and Kinross Council and the neighbour have now indicated that they are happy with the repairs as carried out and we do not anticipate any further costs in this area. The road repairs caused the co-op some serious cashflow issues in 2016 and were part funded with the aid of loans from directors. These loans appear as liabilities in the annual accounts which are prepared to the end of December 2016 – all have now been paid off.


#### **Production**

2016 was a low wind year across the UK with other wind co-ops in Scotland recording production figures down 15-20% on expected figures. However we are pleased to say that taking into account the fact that grid capacity was only available from June 2016, our turbines outperformed expectations for 2016.



The dotted green and solid green lines show the output as projected in the share offer document. The blue dotted line shows revised projected output, taking account of the late start of full generation. Our red production line outperformed the expected output by some 10%.

Generation for 2017 has so far shown actual output tracking expected output closely.



### **Operations**

The turbines have worked well throughout the period with no significant downtime. The largest change has been the need to find a new Operations and Maintenance contractor as RM Energy, our installers, went into receivership in late 2016. We are pleased to say that we now contract direct with WTN, the manufacturers of the turbines, who now have a UK base in Perth. We have worked with them to put in place a new servicing timescale to minimise the likelihood that snow causes problems for routine maintenance.

The Board would like to record its gratitude to RM Energy who worked tirelessly to get the turbines up in very difficult conditions. Sadly their fate has been that of many providers of medium-scale wind turbines, in response to UK policy changes which have virtually halted the sector. To give a graphic example, our Feed-in Tariff is 13.55p/kWh. If we were to build the same turbines now we would have to join a queue to get a non-guaranteed FiT at a rate which has not yet been set but which would not exceed 1.8p!

The Board would also like to thank Mark Jennison of RM Energy who retired from our Board in September 2016 and without whom this project would not have come about.

Wholesale electricity prices have fluctuated wildly in the last year but we were fortunate to be able to sign up a new power purchase agreement in November 2016 near the top of the market at 5.53 p/KWh.

#### **Community Fund**

We have been in contact with Perth College of the University of the Highlands and Islands to let them know that we have had to postpone community fund payments. They will accordingly be aiming to start the bursaries next year as we are on course to be able to commence community fund payments then.

#### Member interest payments

The Society is on course to make its first member interest payments in Spring 2018, barring any significant operational issues between now and then. There is no reason why the Society should not be able to meet the projections made in the share offer from that point onwards. We thank members for their patience and above all for their support.

We hope to see you at the AGM.
